

2020 NATIONAL FINALS RODEO SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE REQUIRED. BUYING WILL NOT HELP YOU WIN. YOUR CHANCES OF WINNING WITHOUT MAKING A PURCHASE ARE THE SAME AS THE CHANCES OF SOMEONE WHO PURCHASES SOMETHING. IT IS ILLEGAL TO GIVE ANY ADVANTAGE TO BUYERS IN A SWEEPSTAKES.

1. ADMINISTRATOR AND SPONSORS: The Sweepstakes (defined below) is run by USFRSC, Inc. dba *Cowboys & Indians* (“Administrator”), 12221 Merit Drive., Suite 1610, Dallas, TX 75251. The sponsors of the Sweepstakes are *Cowboys & Indians*, Wrangler National Finals Rodeo, and Silverton Casino Lodge (“Sponsors”).

2. ENTRY: To enter the 2020 National Finals Rodeo Sweepstakes (the “Sweepstakes”) online, go to www.cowboysindians.com/nfr, follow all entry instructions, and complete and submit the online entry form. Alternatively, you can enter the Sweepstakes by mailing a postcard with your full name, mailing address, and email address (if you have one) to: “2020 NFR Sweepstakes” c/o *Cowboys & Indians*, 12221 Merit Drive., Suite 1610, Dallas, TX 75251. All methods of entry have an equal chance of winning.

3. DEADLINE: Online entries must be received between 12:01 a.m. Central Standard Time on July 1, 2020, and 11:59 p.m. Central Standard Time on September 30, 2020 (the “Entry Period”).

4. LIMIT OF ONE ENTRY PER PERSON. Only one entry is permitted per person. This means that you, personally, can only enter once per Entry Period. You may not register multiple times using different e-mail addresses. If you attempt to register more than once, only the first entry will be considered and subsequent entries will be disqualified.

Entries will be deemed made by the authorized email account holder of the e-mail address submitted at the time of entry. The authorized e-mail account holder is the natural person who is assigned to the e-mail address by an internet access provider, online service provider, or other organization that is responsible for assigning an e-mail address or the domain associated with the submitted e-mail address.

In the event of a dispute about the identity of an entrant, Sponsors may require that the potential winner provide proof that he or she is the authorized e-mail account holder of the e-mail address and/or password associated with the winning entry. Multiple entrants are not permitted to share the same e-mail address for the purposes of entry in the Sweepstakes. Use of any device to automate entry is prohibited.

All entries submitted become the sole property of the Sponsors and will not be acknowledged or returned. The Administrator’s computer is the official time keeping device for the Sweepstakes. “Receipt” of an online entry will be determined when the Administrator’s web server records the registration information. Any automated computer receipt (such as one confirming delivery of email) or other proof of submission of an entry will not constitute actual receipt of a registration form for purposes of these Official Rules (defined below).

The Administrator is not responsible for entries not received, incorrect or inaccurate information whether caused by internet users, difficulty accessing the internet, service outage or delays, computer difficulties, hardware, software, or program malfunctions, any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error which may occur in the processing of the entries.

5. ELIGIBILITY: The Sweepstakes are open to legal residents of the United States, age 21 or older at the time of entry. Void outside of the United States and where prohibited. Employees of Sponsors and their subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members and/or those living in the same household of each, are not eligible to enter. "Immediate family member" means an individual's spouse, parents, spouse's parents, siblings, children, and child's spouse. The Sweepstakes are subject to all applicable federal, state, and local laws and regulations.

Entrants are required to provide truthful information and the Administrator will reject and delete any entry that it discovers to be false or fraudulent. The Administrator will disqualify any entry from individuals who do not meet eligibility requirements. The Administrator will also disqualify and promptly delete any personal information from an entry knowingly received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.

The combined approximate retail value is \$2,064.92.

Total Approximate Retail Value of All Prizes combined: \$2,064.92. Sponsor(s) make no warranties with regard to the prizes. Prizes are not transferable. No substitutions of prize allowed by winners, but Sponsor(s) reserve the right to substitute a prize of equal or greater value due to prize unavailability. 7. PRIZE CONDITIONS: Prize is subject to availability and will be awarded pending verification of eligibility. Hotel blackout dates may apply. It is the winner's responsibility to verify blackout dates and availability before traveling, and arrange ground shuttle transportation with the participating hotel. **All other travel-related expenses not specifically mentioned herein (including airfare, telephone/Internet, in-room hotel services, taxes, and gratuities) are the responsibility of the winner to pay. Entrants also agree that the Administrator and the Sponsors are not responsible or liable for any injury or damage to an entrant's or third person's computer related to or resulting from Sweepstakes and its prizes, including without limitation any server failure; lost, delayed, or corrupted data; or other malfunction.

The Administrator reserves the right to modify, suspend, or cancel the Sweepstakes in the event of any act, occurrence, or reason that would corrupt the integrity, administration or fairness of the Sweepstakes in its sole discretion, including without limitation significant technical difficulties such as those caused by viruses, hacking, unauthorized intervention or fraud. You consent to the personal jurisdiction and venue of the federal, state and local courts in Dallas County, Texas and waive any objections to such personal jurisdiction.

You agree that venue for any dispute arising out of or in any way related to the Sweepstakes and/or these Official Rules lies exclusively in the federal, state, and local courts in Dallas County, Texas.

The Administrator, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of the Administrator’s website. Failure to comply with the rules of the Sweepstakes may result in an entrant’s disqualification and/or forfeiture of any prize or prizes. If the Administrator makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with the Sweepstakes, the Administrator reserves the right to disqualify that entrant from entering and/or winning future sweepstakes and to prosecute and seek damages to the fullest extent permitted by law.
